MEETING OF THE BOARD OF MEDICAL EXAMINERS OF NORTH CAROLINA

Charlotte Hotel, Charlotte, North Carolina
October 27, 1944

A call meeting was held in the Charlotte Hotel at Charlotte, N. C., October 27, 1944. The following doctors were present: J. Street Brewer, Lester A. Crowell, Jr., Karl B. Pace, Frank A. Sharpe, and W. D. James.

Four doctors were licensed at this meeting: James F. Donelly, Jr., Winston-Salem; Walter E. Sharpe, Roanoke, Va.; C. R. Riner, Columbia, S. C.; and James Edward Jones, Murfreesboro, Tenn.

L. P. Chandler, M. C. of Gastonia was summoned before the Board of Medical Examiners. The Bureau of Narcotics informed the board that he was taking twenty grains of morphine a day.

This was the second time he had been summoned. He promised he would take treatment at the U. S. Public Health Hospital, Lexington, Va., a federal institution for drug addicts. He was informed that his license would be revoked unless he did take treatment.

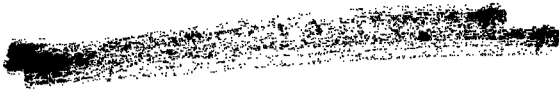
L. H. Justis, M. D. of Littleton was summoned to appear before the board. He admitted being an addict and was sentenced by the U. S. District court on September 25, 1944 to serve one year and a day at the U. S. Public Health Hospital, Lexington, Ky. His license was not revoked. A subpoena was issued to Nathan M. Blalock of Raleigh for violation of the Federal Narcotic law. He did not appear.

Charlie Moore, M. D. of Greensboro license was revoked because of conduct unbecoming to the medical profession. He is serving a sentence in the Federal penitentiary.

J. M. Boyce, M. D. of Polkton, N. C. was granted duplicate license. His license was destroyed by fire July 1939.
