The Board of Medical Examiners of the State of North Carolina met at the Blockade Runner, Wrightsville Beach, North Carolina, October 6-8th, 1972, for the purpose of interviewing physicians applying for license by endorsement of credentials and other business. October 6, 1972 - The Board convened for dinner.

RE: Dr. Harry Duff Riddle, Gastonia, North Carolina, was requested to appear pursuant to a report from the Bureau of Narcotic and Dangerous Drugs and from the Pharmacy Board that he was treating narcotic addicts for withdrawal with methadone. Dr. Riddle came in and went into some detail about the time he was spending with addicts in his treatment and effort to assist them and that if they did not abide by his treatment and directions he refused to breat them. He was advised that the Board was impressed with his dedication; however, that it was apparently irregular to prescribe methadone for as long as 10 weeks unless licensed as a drug center; that was the concensus of most people that addicts should be withdrawn in a period of one or two weeks. After deliberation the Board made the following Verdict: Dr. Joseph W. Hooper, Jr. moved that the Board advise Dr. Riddle that he is in violation of the law and that the Board will not andone what he is doing; that it is imperative that he get within the law. That the Board recommend that Dr. Riddle see Mr. F. E. Epps, Acting Director of the North Carolina Drug Authority within seven days and ascertain that has to be done to abide by the regulations. That Dr. Riddle be requested to report to this Board in writing by November 1st, 1972. This motion was seconded by Dr. Frank Edmondson and passed.

Dr. Riddle was informed by the president of the preceding action. (See file for complete interview).

RE: <u>Dr. Maryjean Heafer</u> appeared August 4th, 1972 applying for license by endorsement of credentials. The meeting was adjourned.

Sunday, October 8th 9:30 A. M.

RE: Fifth Pathway - The secretary presented information with regard to Americans in schools outside of the United States where they do not complete postgraduate training there required to receive an M. D. degree and in turn return to this country for postgraduate training. This matter was discussed by the Board.
