

HEARING MINUTES

The North Carolina Medical Board held its regularly scheduled October 19 - 20, 2017 meeting at the Board's office located at 1203 Front Street, Raleigh, North Carolina. Eleanor E Greene, MD, President, called the meeting to order on Thursday, October 19, 2017, at 8:29 a.m. Board members participating were: Timothy E. Lietz, MD; Bryant A. HEARINGS

CAMPBELL, James Stewart, MD – Pfafftown, NC

The Board was represented by Mr. D. Todd Brosius. Dr. Campbell represented himself.

Dr. Campbell was charged with failing to conform to the standards of acceptable and prevailing medical practice within the meaning of N.C. Gen. Stat. § 90-14(a)(6) with regards to Patients A – H.

At the close of evidence and argument, the Board found that Dr. Campbell failed to conform to the standards of acceptable and prevailing medical practice within the meaning of N.C. Gen. Stat. § 90-14(a)(6) with regards to Patients A – H. The Board voted to revoke Dr. Campbell's medical license.

OKIE, Frederick T, MD – Kansas

The Board was represented by Mr. Brian Blankenship. Dr. Okie did not appear.

Dr. Okie was charged with having his license to practice medicine restricted or acted against by the licensing authority of another jurisdiction within the meaning of N.C. Gen. Stat. § 90-14(a)(13).
